Re: Insurance Certificate - March for Life 2017

"The Risk Management Department has developed a Hold Harmless and Insurance Procurement Agreement known as the "Additional Conditions Attachment" for the parishes and schools to have signed by the bus companies engaged to provide transportation for trips. The purpose of the Additional Conditions Attachment is to control costs whereby following a loss the financial responsibility can be transferred to the bus company to hold us harmless and indemnify us for claims and law suits that arise from the services the bus companies provide.

Prior to the March for Life Pilgrimage, each Parish and School must request the bus company they hire to:

- 1. Sign the Additional Conditions Attachment and provide a copy to the Parish or School. (See the *Additional Conditions Attachment* on reverse side of this page).
  - 2. Provide insurance documentation by way of a Certificate of Insurance that evidences the insurance requirements in items 2&3 of the Attachment, as well as, listing on the Certificate that the Parish/School (by name), the Diocese of Rockville Centre and the Bishop thereof are additional insureds. (Please note the the Risk Management Department has increased the insurance amount the bus company has to evidence on a certificate of insurance from \$3M to \$5M in automobile liability coverage.
- 3. Please be advised that the certificate holder on the Insurance Certificate should reflect the name and address of the Parish or School that has hired the bus company.
